In the Year 3535

This First Amendment to the Global Socialist Constitution established a society based on socialist principles, collective welfare, and social equality. It acknowledges the importance of centralized governance, economic equity, social justice, and loyalty to the ruling party in creating a classless and egalitarian global community.
